Friday 29 March 2019	Deadline for submitting first round of secondary appeals
Monday 29 April-Tuesday 18 June 2019	First round of secondary appeals heard
Wednesday 8 May 2019	Second round allocation day (for applications received 1 November 2018-21 March 2019)
Wednesday 12 June 2019	Deadline for second round of secondary appeals
Wednesday 26 June-Monday 16 September 2019	Second round of secondary appeals heard

Wednesday 24 July-Monday 14 October 2019	Second round of primary appeals heard

AA* case papers sent to appellants, panel and clerk .....	At least 8 working days before date of hearing	*AA = Admission Authority
<b><u>Deadline</u></b> ** for receipt of appellants' additional evidence/information	5 working days before date of hearing	** <b>IMPORTANT:</b> Where full grounds, additional evidence / information is received <u>after this deadline</u> , the Panel must decide (at start of hearing) whether any of this information is to be considered, taking into account its significance and the effect of a possible need to adjourn the hearing.  To be certain all information / evidence is taken into account, it <b>must</b> be received by the specified deadline!
Appellant's additional evidence / information sent to AA, panel and clerk .....	4 working days before date of hearing	
Short decision letter sent .....	Within 1 working day of decision being made	
Full decision letter (with reasons) sent .....	Within 5 working days of decision being made but, e.g. where several appeals for same school, this may be extended to 20 working days
